- 40 CFR Part 61, Subpart M (Complete Rule)
- 40 CFR §61.145—Standard for demolition and renovation
- 40 CFR §61.150—Standard for waste disposal for manufacturing, fabricating, demolition, renovation, and spraying operations
- OSHA 29 CFR 1926.1101 Asbestos General Standard—Specification of permissible exposure limits, engineering controls, worker training, labeling, respiratory protection, and disposal of asbestos waste
- 29 CFR 1910.1001
- OSHA 29 CFR 1926.1101 Asbestos Construction Standard—Covers construction work involving asbestos, including work practices during demolition and renovation, worker training, disposal of asbestos waste, and specification of permissible exposure limits

NVLAP (National Voluntary Laboratory Accreditation Program)
